Frankfurt, 14 August 2025 Bockholdt GmbH was merged into STRABAG Property and Facility Services GmbH (STRABAG PFS) on 7 August 2025. This step completes the strategic integration of the North German cleaning services provider, which STRABAG PFS acquired in December 2022. One of the largest employers in northern Germany, with 13 locations and around 3,600 employees, will now operate under the unified name STRABAG PFS.
